Why Membership in the California Physical Therapy Association (CPTA) is Important

- CPTA is the only organization advocating for legislative and public policy issues affecting the PT profession in California. The Physical Therapy Board of California protects consumers, not physical therapists.
- Without CPTA, you would not have access to quality continuing education, guidance on practice issues, networking opportunities, employment and patient referral services, advertising and research grant opportunities as well as public relations support to promote the benefits of physical therapy. *CPTA is the ONLY organization protecting the right of physical therapists to practice physical therapy.*

CPTA Membership – It is less expensive to protect your profession than your home, your car and your health.

Membership is only \$1.47 per day for a PT and \$0.94 per day for a PTA (based on \$540 for PT and \$346 for PTA). This is a small price to pay to ensure you can continue to practice physical therapy on a daily basis.

Member Services

- **Expert Staff** - Full-time staff members answer the phones Monday through Friday to respond to your questions.
- **Legislative Advocacy** - CPTA closely tracks hundreds of bills every year for their potential impact on physical therapy in California. Dues supported legislation for mandatory continuing education requirements, direct access for health and wellness services, the ability to use the title “Doctor” and unrestricted direct access for all patients. In 2007, CPTA initiated a repeal of transmittal 65 which would have prevented PTAs from treating Medicare patients.
- **Public Relations** - CPTA educates members on how to promote physical therapy to our patients. Our website offers several evidence-based presentations to educate legislators and the public on our services. New *MoveCalifornia* modules are created every year for the *MoveCalifornia* campaign.
- **Continuing Education** - CPTA provides members with high-quality continuing education throughout the year via webinars, the annual conference and on-site courses. CPTA courses cost 60 percent less for CPTA members.
- **Payment Advocacy** - CPTA makes available an expert in payment policy to answer your questions and provide timely updates on payment policy changes and trends. In 2008, our efforts prevented Blue Cross from cutting payments by 75 percent per clinic.
- **Vendor Products and Discounts** - CPTA provides members with services at reduced rates, including workers’ compensation, conference call services, an AED package and government and administrative legal assistance. Affordable debt-collection programs and professional liability coverage are also offered.
- **CPTA Sponsors Legislative Day, Chapter Annual Conference, Capitol Wellness Day** and other opportunities for education, networking and lobbying.
- **Member Communications** - Website, newsletter, public outreach, PT journal and *California PT Notes*.
