

## **Recent Successes in Grassroots Advocacy**

### **January 13, 2010 – Local physical therapists meet with Assembly Member Joel Anderson to discuss AB 1152 (Professional Corporations: Licensed Physical Therapists)**

John C. Gray, DPT, along with sixteen other physical therapists met with Assemblyman Joel Anderson to discuss AB 1152. Sixteen physical therapists were from the San Diego District, thirteen of which live and work in Assemblyman Anderson's 77<sup>th</sup> District. A DPT student from the University of St. Augustine was also in attendance. After voicing CPTA's opposition to AB 1152 Assemblyman Anderson chose to remove the bill as currently written from committee. The language of AB 1152 was amended to exclude physical therapists and now pertains to horse racing. The CPTA would like to thank John C. Gray for leading the local grassroots effort to defeat AB 1152 and the physical therapists and students who joined him in this fight.

### **January 11, 2010 – University of the Pacific Student Legislative Day in Sacramento**

Over 30 physical therapy students from the University of the Pacific gathered at the Capitol on Tuesday, January 11 to meet with 30 state representatives in the California legislature. The students were given the opportunity to discuss the education of physical therapists in California, the importance of physical fitness and consumer direct access to physical therapist services. The students were given a crash course in legislative advocacy by CPTA's most active members. This event served as a great learning experience for these young professionals as they were given the tools necessary to continue their advocacy efforts at the local level. We would like to thank the CPTA members who volunteered their time to mentor the students and we look forward to organizing our next Student Legislative Day event.

### **December 4, 2009 – Fundraiser for Senator Gloria Negrete-McLeod in Montclair, California**

A fundraiser was held in Montclair, California for California State Senator Gloria Negrete-McLeod. The fundraiser was a joint effort on the Inland Counties District of the California Chapter and CPTA leadership. Over 40 guests were present. CPTA members and non-members were given the opportunity to meet with the Senator and discuss issues most important to physical therapy. We would like to thank all of those guests for their participation and support.

### **November 20, 2009 – Fundraiser for Senator Dean Florez in Fresno, California**

A fundraiser was held in Fresno to raise money for Senator Dean Florez who has announced his candidacy for Lt. Governor in 2010. The fundraiser was a joint effort of the San Joaquin Valley Chapter and the California Private Practice Group SIG. The fundraiser was attended by 23 San Joaquin Valley District PT's, as well as PT and Non PT students from CSU, Fresno and the Government Affairs Chair of the CA PPG SIG.

Senator Florez spoke about several issues at the event, noting the importance of the role of Lt. Governor pointing out that in the last 4 years 4 Lt. Governor's have moved into the Governor's seat mid-term. Senator Florez also recognized the importance of constituents meeting one on one with elected officials to address issues of concern. Senator Florez noted that in the past Physical Therapy issues rarely came up in the legislature, recently legislation involving Physical Therapy have appeared repeatedly during the course of the year, in fact there were 125 individual pieces of legislation during the past legislative year.
